2012 TERMS OF ENROLLMENT

TO: Gregory C. Pierce: You may register my child(ren) for the 2012 summer season into Pierce Camp Birchmont as indicated on the reverse side of this enrollment contract/agreement. This enrollment application shall not be valid unless signed below by the Parent or Guardian of the Camper and by the Camp Director as having accepted the enrollment.

You must sign the reverse side of this contract.

- **Tuition:** Tuition covers all regular camp activities, laundry twice weekly, round trip transportation (opening day transportation only for Rookie Camp) from locations in Boston, Darien or New York and limited accident medical insurance. **The cost for the Full Session for the summer of 2012 is \$9,950.00. The cost for the 1st Session is \$6,425.00; the 2nd Session is \$5,100.00; Rookie Camp is \$3,000.00. All campers are responsible for a non-refundable Trips/Special Activities Account. A payment of \$1,000.00 per camper must accompany the enrollment to ensure acceptance. A payment of \$1,500.00 per camper is due January 1, 2012, with the balance due by April 1, 2012.** There is a 5% tuition discount on the second child in a family and a 10% discount on the third child in a family. Discounts only apply if tuition is paid according to the contract. We reserve the right to cancel this application if fees are not paid in full by April 1st. An additional charge of 1.5 % monthly will accrue on any unpaid balance beginning June 1st and monthly thereafter until payment is complete. In the event of delinquent payment, Parent agrees to pay all legal costs incurred during the collection process.
- **Credit Card:** You have the option to pay all or part of your tuition by credit card. Any unpaid miscellaneous charges such as camp store, horseback riding, medical bills, etc. will be automatically charged to your credit card at the end of your child(ren)'s session.
- **Optional/Additional Charges:** Senior multiple day trips (Canada, Whitewater Rafting, Boston), Senior HPI Tennis Program, Golf Outings, Horseback Riding and Camp Store purchases are additional. If additional transportation is necessary, charges are \$150.00 for Boston's Logan Airport and \$100.00 for either Manchester Airport, NH, or Portland International Jetport, ME.
- **Refunds:** Per camper refunds will be made in full on any cancellations prior to Jan. 1st less a \$300.00 non-refundable application fee. Thereafter, there will be a cancellation fee of \$1,000.00 between Jan. 1st & March 31st; \$2,000.00 between April 1st & April 30th, and \$3,500.00 between May 1st & May 31st. **AFTER MAY 31st there will be no refunds and no camper will be allowed to convert from a full session enrollment to a half session due to the seasonal nature of camp enrollment patterns.** Additionally, there will be no allowances or refunds made for late arrival, early departure, or absences without the Director's consent prior to the camp season.
- **Camper Medical information:** Parent must inform the Director prior to registration if Camper has received professional counseling or medication for behavioral modification during the last 12 months. Parent must also inform Director immediately if such care or medication occurs after registration and prior to the camp season. Failure to inform Director may lead to dismissal of Camper from camp without a refund.
- **Images:** We hereby consent to and authorize the reproduction, publication and use by Camp and the American Camping Association and their successors and assignees for advertising, commercial, or any other purposes, any photograph, picture or likeness of, art or audio recordings of my/our child, including any images on the Camp website. Parent grants permission to use any photograph, film or other image for promotional purposes, including but not limited to brochures, DVDs, our website and Facebook page and other on-line postings.
- **Trips:** Consent is hereby granted for transportation to and from any and all camp activities and programs.
- **Belongings:** Camp is not responsible for Camper's belongings or equipment while in transit or at camp.
- **Camp Policies:** Gratuities in any form for staff is prohibited. The Camper and Parents agree to abide by all of the rules and regulations established by the Camp including, without limitation, those relating to visitation, telephone communication, enrollment and withdrawal of Camper.
- **Release of Camper:** The Camp will only release a Camper(s) to the parent or legal guardian who signed this contract, or with permission *in writing* stating otherwise.
- **Dismissal of Camper:** The Camp reserves the right to dismiss, in its sole discretion, any Camper whose condition, conduct, influence or behavior is deemed unsatisfactory or detrimental to the best interests of the Camp or his fellow campers or who violates camp rules and regulations. We acknowledge that the Camp cannot replace the camper once the season has started, and Parent will not be entitled to any refunds.
- **Assumption of Risk:** I understand that part of the camping experience involves activities and group living arrangements and interactions that may be new to my child, and that they come with certain risks and uncertainties beyond what my child may be used to dealing with at home. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk-free, and so I have instructed my child on the importance of abiding by the camp's rules and policies, and my child and I both agree that he or she is familiar with these rules and policies, and will obey them. The Camp is not responsible for events beyond its control, force majeure events, epidemics, acts of third parties, etc. The Camp is not responsible for injuries to the Camper which occur during the ordinary course of camp activities.
- **Jurisdictional Clause:** It is agreed that any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, can only be brought in a court of competent jurisdiction located in Carroll County New Hampshire and shall be construed in accordance with the laws of New Hampshire.
